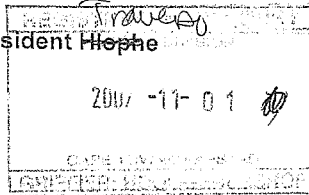

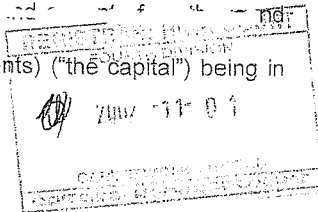

ORDER

By agreement between the parties and in full and final settlement of Plaintiff's claims in both her personal and representative capacities herein, arising out of the collision on 19 March 2004, it is ordered that:

THE CAPITAL

1. Defendant shall pay to the Plaintiff's attorneys the sum of R 1 000 000 (One million South African Rand) and nine hundred and fifty-two and eleven cents ("the capital") being in



respect of Plaintiff's personal claim in the amount of R 100,000.00 and in her representative capacity in the amount of R 100,000.00, by way of a lump sum payment ("the capital payment") in the manner and on the date set out in paragraph 2 hereunder.

Defendant shall pay the capital payment on or before 28 November 2007 by way of electronic transfer to the trust account, details of which are set out hereunder.

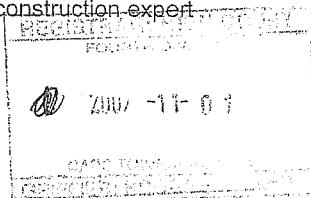
COSTS

The Defendant shall pay the Plaintiff's taxed or agreed costs on the High Court scale as between party and party including any costs attendant upon the obtaining of payment of the capital amount.

Without limiting the foregoing the said taxed or agreed costs are to include *inter alia* the following:

4.1. with regard to the expert witnesses hereinbelow ("the experts"), the taxed or agreed fees and qualifying expenses, all costs attached to the procurement of reports including the costs of attending all necessary consultations, as well as any other related costs, of the following experts:

- (a) Professor T Dreyer, accident reconstruction expert
- (b) Mr Jan Rens, land surveyor

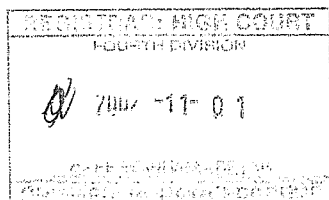


- (c) P W Ennis, actuary
- (d) Mr C P J Bester, accountant
- (e) Mr Danie Cillié, agricultural economist

The taxed or agreed fees of Plaintiff's senior counsel, which fees are *inter alia* to include perusal of documents, legal research, preparation for consultations and trial, consultations with witnesses and travelling to and attendances at inspections *in loco*, consultations and attendances with Plaintiff's attorney and Defendants' legal representatives.

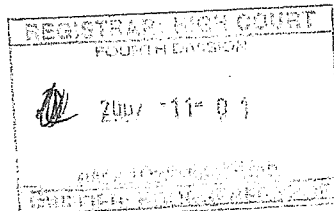
4.4. Should the bill of costs require to be taxed it will be taxed at the offices and under the auspices of the Arbitration Forum, Cape Town.

PAYMENT PROVISIONS

5. The payment provisions in respect of the foregoing are agreed as follows:

5.1. Payment of the capital payment shall be effected, on the date as specified hereinabove, direct to the Plaintiff's attorneys of record by means of electronic transfer to the account listed hereinbelow.

5.2. Payment of the taxed or agreed costs reflected above shall be effected within 14 (fourteen) calendar days of agreement or taxation ("the due date") and shall likewise be effected by electronic transfer to the account listed hereinbelow.



5.3. Should the costs or capital not be paid by the due date, the Defendant will be liable for interest thereon at the prescribed statutory rate.
